NOTICE OF RACE

The Regatta activities must be carried out in accordance with the provision on the flight and containment of diffusion of COVID19 issued by Italian Sailing Federation. The Organizing Committees will activate these provision and all participants must adhere under the supervision of the Organizing Committee itself.

In the case of any cases of Covid 19 will be detected during the event. These will be reported by the Organization Committee to the component health authorities in charge.

The notation [DP] in a rule of Notice of Race (NOR) means that the penalty for breach of that rule may, at the discreption of the Jury, be less than disqualification.

1 – ORGANIZING COMMITTEE

The 420 Jean Bertrand 2020 is organized by the Yacht Club Sanremo under delegation of Italian Sailing Federation.

2 – RULES

2.1 – The regatta will be governed by the rules as defined in The Racing Rules of Sailing.

2.2 – National authority prescriptions will apply.

2.3 – The official language of the event is English.

3 – ADVERTISING AND OTHER IDENTIFICATION

3.1 – Boats may be required to display advertising and identification stickers chosen and supplied by the organizing authority, in accordance with Regulation 20.

3.2 -The Organizing Authority reserves the right to refuse advertising by a boat or competitor when it is in conflict with the laws of the Italian government or Italian Sailing Federation.

3.3 – Boats of 470 Women and 420 Ladies classes shall carry the red square identification on both side of the mainsail.

4 – ELIGIBILITY AND ENTRY

4.1 – The event is open to following classes: 420 Man & Mixed, Woman, Under 17.

4.2 – Eligible boats may enter by completing the form available online at www.yachtclubsanremo.it and paying the relevant entry fee on 28 October , 2020.

All boats competing in this event shall have third party insurance cover not less than 1.500,000 EURO for any accident. Each competitor shall produce at Registration evidence of such insurance and any competitor not holding this cover shall withdraw their entry.

A copy of the Insurance shall be preliminary sent during the on-line registration and then also produced at Registration office during the final Registration procedures.

11 – SCORING

11.1 – One race is required to be completed to constitute a series.

11.2 – Discards:

a) When from 1 to 3 races have been completed, a boat's series score will be the total of her race scores.

b) When from 4 to 19 valid races have been completed, a boats series score will be the total of her races scores excluding her worst score.

12 – BOATS OF SUPPORT PERSONS

12.1 Boats of support persons shall be marked with a flag or sticker supplied by the organization and shall register at the registration desk before 10.00 a.m. of 21 February.

12.2 – Evidence of Third Party insurance for each support boat shall be produced during registration.

13 – BERTHING

Boats shall be kept in their assigned area in the boat park.

14 – PRIZES

Prizes will be given to the first, second and third boat of the Overall ..First Woman . First Mixed and First U17 Other special prizes could be announced in the SI.

15 – DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. 16.2 –The Organizing Authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
