NOTICE OF RACE

The regatta activities must be carried out in accordance with the provisions to combat and contain the spread of COVID 19 issued by the Italian Sailing Federation. The Organizing Committees will activate these provisions and all participants must adhere under the supervision of the Organizing Committee itself.

In the case that any cases of Covid 19 will be detected during the event, these will be reported by the Organizing Committee to the competent health authorities in charge.

The notations in a rule: **[DP]** means that a penalty for breach of that rule may, at the discretion of the Jury, be less than disqualification. **[NP]** means that a boat can't protest for a breach of this rule.

2. RULES

2.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing 2021-2024 included valid Prescriptions of the Italian Sailing Federation FIV, which are available in English at: https://www.sailing.org/documents/racingrules/national_prescriptions.php and which will be posted in the on line ONB.

2.2 **[DP][NP]** The special regulation “LINEE GUIDA PER LO SVOLGIMENTO DELL’ATTIVITA’ BASE E COMPETIZIONI SPORTIVE” e “RACCOMANDAZIONE PER L’APPLICAZIONE DI MISURE ULTERIORI DI PREVENZIONE IN OCCASIONE DI COMPETIZIONI VELICHE” (further referenced to as “Covid Protocol”), issued by National Authority Federazione Italiana Vela FIV (Italian Sailing Federation), version updated January 10th, 2022 published on <https://www.federvela.it/news/3151-covid-19-aggiornate-le-linee-guida-per-lo-svolgimento-dell%E2%80%99attivita%C3%A0-di-base-e-le-competizioni-sportive.html>, constitutes an integration to the previous one “PROTOCOLLO DI REGOLAMENTAZIONE DELLE MISURE PER IL CONTRASTO ED IL CONTENIMENTO DELLA DIFFUSIONE DEL COVID-19 NELLE SOCIETÀ E ASSOCIAZIONI SPORTIVE AFFILIATE” (version updated October 8th, 2020 or any subsequent versions, published on <http://www.federvela.it/news/2718-aggiornato-il-protocollo-di-sicurezza-federazione-italiana-vela.html>.)

2.4 In the event of conflict between the Notice of Race and the Sailing Instructions, the Sailing Instructions shall prevail (this changes RRS 63.7).

2.5 If there is a conflict between languages the English text will take precedence.

2.6 - The weight crew restrictions of the class rule 13.30 shall not apply.

2.7 – For the Italians competitors the “Normativa” of the National Authority FIV (Italian Sailing Federation) will apply.

3. COMMUNICATIONS

In compliance with Covid Protocol, Official Notice Board (ONB), communications to competitors and from competitors to the OA, CR and Jury, shall be done only as an Online Official Notice Board, available at the following link: <https://www.racingrulesofsailing.org/documents/3231/event> or QR Code:



4. ELIGIBILITY

4.1 - WS Regulation 19 “Eligibility Code” applies.

4.2 - Only International Dragon Class yachts holding valid Measurement Certificates shall compete.

5. ENTRIES AND FEES.

5.1 The Entry Form, in the website of the Yacht Club Sanremo, shall be filled within March 03th, 2022 completed by:

- Copy insurance’s company statement as per annex, with a minimum cover of € 1.500.000,00 per event

- Copy of valid measurement certificate.

- The entry fee can to be paid in a second time or at the registration time.

5.2 The entry fee is € 500,00 to be paid to IBAN: **IT 54T 06175 22700 00000 3037980**, SWIFT/BIC: **CRGEITGG301** - Banca Carige, beneficiary: Yacht Club Sanremo, specifying the sail number of the entering boat. The entry fee includes crane fees for one hauling-in and one hauling-out, and all social events as described in section 7 “Race Schedule”. Payment of the registration is not refundable.

5.3 A delayed entry, after March 3th, can to be accepted at discretion of the OA by a penalty of € 100.

5.4 The “Corinthian” crews, i.e. crews composed by Group 1 sailors only, shall declare their intention to compete in the Corinthian classification in the entry form, as per Regulation 22 “Sailor Categorization Code” (Ref. WS Regulation 22.4.5).

6. MEASUREMENT AND EQUIPMENT INSPECTIONS

6.1 - Inspections may be carried out on boats and/or equipment prior, during and after the races following the request of the Race Committee or Jury.

6.2 - No measurement will be available at the event.

All boats and sails shall be already measured and approved to be in compliance with Class Rules in advance to the event.

7. RACE SCHEDULE

- 7.1 8 Races are scheduled and no more than 2 races shall be raced on per day.

- 7.2 Overall Event Schedule:

Sunday 20th March No warning signal will be made after 2.30 pm.

- ASAP after races daily and final, there will be the prize giving ceremony.

7.3 - The Race Committee may sail up to two races per day. A third race may be sailed in case of delay or forecast of delay on the schedule. This third race will be signaled by the RC displaying the flag "G" after the end of the second daily race.

7.4 - The scheduled time of the first warning signal of each day after the first day will be posted on the ONB before 08.00 pm of the previous day. Where no new notice is posted, the first warning signal of the next day will be the same as the warning signal of the previous day.

7.5 - The Organizing Committee may modify the race schedule in case of adverse weather or any other circumstance.

8. COURSES

Races will be windward/leeward courses in the Gulf of Sanremo as described in the Sailing Instructions

9. PRIZES

Prizes will be awarded to: - The first three boats overall.- Others eventual prizes at OA discretion

10. SAILING INSTRUCTIONS

Appendix S "Standard Sailing Instructions" applies. Standard Sailing Instructions and Supplementary Sailing Instructions shall be posted on the ONB.

11. SCORING

11.1 - A maximum of eight (8) races will be sailed. The low points scoring system of Appendix A of WS RRS will apply.

11.2 When fewer than 5 races have been completed, a boat's series score will be the total of her race scores; when 5 or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

12. DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See rule 3, Decision to Race. The Organizing Authority will not accept any liability for material damage or personal injury, or death sustained in conjunction with or prior to, during, or after the regatta.

Recalling the Fundamental Principle that mentions: "Participants are invited to minimize any negative environmental impact of the sport of sailing", it is recommended that the utmost attention be paid to protecting the environment in all moments that accompany the practice of the sport of sailing first, during and after the event. In particular, attention is drawn to RRS 47 - Waste Disposal - which reads: "Competitors and support persons must not deliberately throw waste into the water. This rule always applies when in the water. The sanction for an infringement of this rule may be less than disqualification

13. INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of 1.500.000€ per event or the equivalent. Alternatively, you can fill in the attached form to be signed and stamped by your Insurance Company.

13. MEDIA RIGHTS

By entering this event yacht owners, their crew members, and guests give the Organizing Authority and its sponsors the rights and authorization to publish and/or distribute, via any media, photographs and videos of people and boats made during the event, even for press release and/or advertising.
